What is this research about?

Learning from experiences playing games during the Pandemic, we want to explore how we can design boardgames or artefacts that can be played by people who aren't in the same place, or used by people who aren't in the same place to maintain their connection to boardgames. We're particularly interested in what games and artefacts can tell us about improving the experience of boardgaming and other hobbies for people who can't be in the same place.

What will I be asked to do?

Should you agree to participate, you will be asked to comment on the artefact which we have provided to your friend. You can comment on what you would (or would not) use it for, what you think it could do, how it might add value to your gaming experiences, or simply be in a photo with the artefact. You are welcome to add your comments to the back page of your friend's provided diary or to write them on a separate page which they will include with their diary. Note that your friend will be able to see what you write, unless you put it in an envelope.

What are the possible benefits?

Your comments or photos will help us to understand how people might use physical artefacts to augment their participation in boardgaming. If you are a University of Melbourne student, participating will not affect your grades.

What are the possible risks?

We have not identified any serious risks associated with your participation in the study. You're already spending time with your friend.

It is possible that you might be identifiable in a photo or in your comments. We will anonymise all participant names in our research, but we might use photos in conference presentations or in published research papers.

Do I have to take part?

No. Participation is completely voluntary. You are able to withdraw at any time. We will avoid using any direct quotes from you or pictures of your diary and will delete interview records. We are not able to remove photos or text after material has been published.

Will I hear about the results of this project?

We will publish the results of the project in academic venues, which can be found through the researchers' "Find an Expert" pages at The University of Melbourne. We will also share information through the researchers' social media channels, which we will share with you if you are interested. What will happen to information about me?
